VALID PURSUIT settled off the pace, was coaxed along while three then two wide on the turn, came under stronger urging after turning into the stretch, advanced to loom a major threat coming to the furlong marker, steadied behind the leading trio at that point then altered course to the rail, surged through along the fence in the final sixteenth and got up under good handling. PERFECT SOCKS was well placed just off the pace, went two then three wide on the turn, spun four wide into the stretch, made an outside bid at the furlong marker, led into the final sixteenth but was caught while able to get the place. NORTHWOODS CAT tracked the leading duo on the outside, made a bid in the three path on the turn, came under a drive in upper stretch, battled between horses from the eighth-pole to the sixteenth-pole then was outfinished while able to get the show. YANKEE GAMBLER disputed the pace on the outside, vied in the two path on the turn, was asked for his best in upper stretch, battled until near the sixteenth-pole then weakened. NORTH HULLEN contested the pace on the inside of YANKEE GAMBLER, vied along the rail on the turn, dropped back late on that bend and tired. A WE BIT FLIRTY was urged along on the outside, went three wide on the turn, swung six wide into the stretch and failed to rally. TEN TO MIDNIGHT dropped well behind, saved ground on the turn and was no factor. WAR THREAT settled towards the front on the outside, was urged along while four wide on the turn, spun five wide into the stretch and came up empty. ASHLEY'S LONDON was urged along while inside of A WE BIT FLIRTY, went three wide on the turn, came four wide into the stretch and never reached contention. ZARBY'S DERBY DAY settled towards the rear, moved out late on the backstretch, rounded the turn in the five path, floated six wide into the stretch and showed little. MR. ERIN settled off the pace, saved ground on the turn and failed to respond. AARON OF GOSHEN lacked early speed, saved ground on the turn and was outrun.
