KID CREOLE bumped with a rival at the start, settled off the pace, went around the turn in the two to three path, shifted four wide into the stretch, moved out while put to a drive at the three-sixteenths, rallied outside under a right-handed whip, switched to a left-handed whip while gaining approaching the sixteenth-pole, went back to a right-handed whip late and got up near the wire. JAKE THE BAND MAN showed good speed and set the pace, vied inside to the two path on the turn, was asked outside the quarter-pole, dueled gamely with SPECIALEYES in the stretch and narrowly defeated that foe for the place but was denied by the winner. SPECIALEYES tracked the pace, engaged the leader in the two to three path on the turn, was asked once straightened for the drive, dueled gamely with JAKE THE BAND MAN in the stretch and just missed while clear for the show. IT'S MIKE'S TURN raced just off the pace on the outside, was coaxed along in the three to four path on the turn, drifted out a bit while put to a drive in upper stretch and was out-kicked but earned the last spot in the superfecta. COUNTACH drifted in early, moved up on the inside to race just off the pace, dropped back some leaving the backstretch, rounded the turn in the two path, was put to a drive in upper stretch and was also out-kicked. MEDIAMAKER bumped with a rival at the start and was off a step slow, was urged along at the rear, saved ground on the turn, came under the whip in upper stretch and failed to rally. CASE'S TICKET was hustled from the start, chased the pace, bumped repeatedly with LOGAN'S REWARD from the half-mile pole to the seven-sixteenths pole, lost position at that point, was urged along in the two path on the turn and came up empty. LOGAN'S REWARD raced just off the pace between horses, bumped repeatedly with CASE'S TICKET from the half-mile pole to the seven-sixteenths pole, went three then four wide on the turn and failed to respond.
